Tender schedules without EMD or less EMD will be summarily rejected.

Contractors registered with APSRTC should submit copy of certificate of registration & experience certificate along with application. The Contractors who have not registered with APSRTC should submit the application along with proof of registration of other departments, solvency & experience certificate etc., If required information is not submitted along with application, tender schedules will not be issued.
