- 3. The EMD will not carry any interest. The EMD of the unsuccessful tenderers will be refunded only after finalization of Tenders.

- 4. The License period is for Five(5) years. The license period commences from 30 days from the date of issue of the Letter of Allotment or the date of execution of the license Agreement which ever is earlier.
- Maximum price for the bid for installation & maintenance of smart TVs in buses during first year of the contract period is Rs.1,295/- per bus per month, exclusive of applicable Taxes.
- Monthly remuneration per bus per month payable to the Contractor by the Corporation shall be enhanced @4% over previous year from 2<sup>nd</sup> year onwards.

- 7. The bidder shall quote equal to or less than the maximum payable amount to the Contractor by the Corporation per bus per month exclusive of applicable taxes (Maximum price for the bid)
- 8. Bids more than the maximum price( Rs.1,295/-) for the bid will not be accepted. Such tender application will be treated as invalid duly forfeiting the EMD amount.
- 9. The tenderer who quotes the lowest amount per bus per month payable to the Contractor by the Corporation in tenders(L.1) is the successful bidder.
- The Tender Committee will negotiate with the successful bidder in the tenders for further reduction of the quoted amount, if desires so.
- 11. In case the L.1 bidder withdraws from the bid or is not selected/considered for any reason, the Corporation reserves the right to invite the second lowest bidder(L.2) to offer revised bid lower than or to match with the lowest offer of the L.1 bidder.
- 12. The Corporation also reserves the right to negotiate with the next lowest bidder (L.3). If L.2 bidder does not revise the bid to lower than or to match with the lowest offer the L.1 bidder.
- 13. If two tenderers quote the same amount the decision of the Tender Committee in awarding the contract is final basing on the experience in the relevant field.
- 14. The Contractor shall load 30 Movies in 64 GB Pen drive and supply to each bus at his own cost. The movies loaded in the pen drive shall be changed every month and the list of movies loaded in each Pen Drive shall be perused and approved by DM/Traffic In-Charge of the Depot.

- 15. Tender Schedule: -
- a). Sale of application commences from 08.02.2025 to 19.02.2025 up to 5.00 pm.
- b). Dropping of applications in the tender box from 10.30hrs to 2.00 pm. on 20.02.2025
- c). Opening of Tenders box 3.00pm on 20.02.2025.
- 16. Before submission of the Tender, tenderers are required to make themselves fully conversant with the eligibility, terms and conditions, so that no ambiguity arises at a later date in this respect.
- 17. In the event of the dates specified for receipt and opening of Tender, being declared as a holiday for APSRTC's office, the due date for submission of Tenders and opening of Tenders will be the following working day.
- 18. APSRTC reserves the right to accept any Tender or reject/cancel any tender or all the tenders received in response to this tender notification at any stage without assigning any reasons whatsoever.
