GENERAL INSTRUCTIONS

- 1) For Stalls reserved/earmarked for SC/ST/PEBC only members of SC/ST/PEBC candidates have to submit tenders duly enclosing the Caste Certificate and Income Certificate issued by MRO.
- 2) The integrated Caste/Community Certificates should have been issued not earlier than three years as on the date of publication of tender notice.
- 3) The BC candidates whose gross annual income is below **Rs.8.0** lakhs per annum shall only come under PEBC category and are eligible for participating in the tenders called for the stalls earmarked for SC/ST/PEBC.
- 4) The EMD amount shall be drawn through Demand Draft in favour of Accounts Officer, APPTD, Palnadu District, Narasaraopet.
- 5) In the event of EMD being paid is less than what is stipulated in the Tender Notification or the EMD is paid through other means i.e., in a manner other than stipulated in the tender notification, it shall be forfeited to the Corporation funds without any notice.
- 6) In the event of EMD being paid is less than what is stipulated in the Tender Notification or the EMD is paid through other means i.e., in a manner other than stipulated in the tender notification, it shall be forfeited to the Corporation funds without any notice.

- 7) The minimum business period is one year. If any of the licensee wishes to close the business before stipulated minimum period, they have to pay balance amount for left over minimum period.
- When tender application is purchased by one person and tender submitted in another person name which tender is treated as invalid and Rs.10,000/- or 25% of EMD whichever is less will be deducted as penalty.
- When incomplete tender form is submitted or tender form with pre-conditions or additional conditions is submitted by the tenderer the EMD will be forfeited to the Corporation.
- 10) If an open space is allotted to the licensee, he/she has to erect temporary structures at his/her own cost with the prior approval of the licensor.
- 11) The intending tenderer must visit premises of Stall/Shop physically to have clear idea before submitting the tender and only after getting satisfied about the Shop/Stall shall participate in tenders and no modification of structures/area will be considered after finalization of Tenders.
- 12) The successful bidder has to make his own arrangements to clear the road side unauthorised occupations. Bidder has to make sure in participating tenders, keep in view that clearance of road side occupations will be the responsibility of the bidder.
- 13) The temporary construction shall be constructed not more than 13 feet height only from road level.
- 14) If the tender is submitted on behalf of a firm, name of the person representing the firm along with designation shall be mentioned in the tender form below the firm's name. Also, proof of authorization shall be submit along with tender document.
- 15) The tender must be unconditional. Conditional offers will be summarily rejected duly forfeiting the EMD. The amount quoted by the Tenderer shall be entirely in Indian Rupees only.
- 16) The Property Tax and any other taxes levied by the Government/ local bodies and other organizations shall be collected from the licensee.
- 17) The EMD amount for each stall will be received separately in the form of Demand Draft drawn in favour of Accounts Officer, Palnadu District, Narasaraopet, APPTD, Demand Draft in favour of any other officer will be rejected.
- 18) The cost of tender form for 'B' class Bus Stations is Rs.885.00 (including GST @ 18%)and 'C' class Bus Stations is Rs.295-00 (including GST @ 18%).
- 19) Before submission of the tender, tenderers are required to make themselves fully conversant with the terms and conditions, so than no ambiguity arises at a later date in this respect.
